The current study examines the relationship that motivation for social media use has on narcissism and empathy. Meta-analyses indicate a pattern of increases in narcissism and decreases in empathy among younger Americans (CITATION). What is explaining this relationship? Previous literature indicates that motivation for social media use is related to narcissism and emotional recognition abilities (CITATION). Previous literature examines narcissism in relation to social media (CITATION). The present study aims to assess how attention-seeking motivation for social media use explains the relationship between narcissism and empathy. The present study also aims to assess how the two types of narcissism, grandiose and vulnerable, relate to empathy and motivation for social media usage. The hypotheses of the study are that the relationship between narcissism and empathy is mediated by attention-seeking motivation for social media use and grandiose narcissism will be a

stronger predictor of attention-seeking motivation for social media use than vulnerable narcissism. The present study will examine how motivation for social media use is related to trait narcissism and empathic ability.

I will recruit approximately 250 participants. My participant pool will comprise of CCSU undergraduates and participants who voluntarily fill out the online survey. The demographics of the participants will depend on who completes the online survey voluntarily.

Participants who do not have a Facebook or Instagram account will be excluded from the study.

None of the participants will be minors, children, prisoners, students, employees, individuals with impaired decision-making capacity, or economically or educationally disadvantaged persons.

Previous research investigating the relationship between narcissism and social media use has run participants with similar demographics and it is important to run such participant in the present study to replicate previous findings and to related potential findings from the proposed study with previous findings. To prevent or minimize any potential undue influence or coercion no benefits are provided to the participants for participating in the study. Participants may exit the survey at anytime. Some participants may be students of the proposed study nor mention to Psychology" course. Will not mention to his students that he is involved in the proposed study nor mention that they should run this study because he is involved in it.

The present study aims to examine motivation for social media use across demographics, but excludes those under 18 and over 60 because of consent purposes and relevance to the effects of social media use and psychological well-being.

The data will be collected online by sending electronic links to the surveys. The Lead Investigator, may also administer the proposed research procedures in person. This will be done on the CCSU campus in rooms designated in SONA and/or in psychology department for running participants

Deception: The design of my study requires that the participants are not told the real goal of the study or else their responses may be affected in a way that will make the result from the study uninterpretable. Each participant will receive a debriefing explaining the goals of the study (see Appendix H for debriefing.)

There are no known risks of physical or psychological damage associated with participating in this study. This judgment is based on a large body of experience with similar types of research study. A possible inconvenience is that some participants have found similar tasks to be slightly fatiguing.


