Billing & Payment

All bills are electronic, and students are notified by email when they are posted. Bills are due on July 15 for the Fall semester

In order to view and pay your bill, students need to activate their BlueNet UserID and password at **Central Accounts Management**. Be sure to have your student make the payment by the due dates to avoid any late fees or holds on their account.

Payments can be made in Cash, eCheck, Credit Card, Personal Check, Cashier's Check or Money Order, TransferMate (International Student Payments) and/or Wire Transfer. For more information on Payment Methods.

Math & Writing Placement

Math and writing classes are required to graduate, and must be taken within a student's first year at Central. Academic advisors base class placement on SAT/ACT scores or Central placement test scores. If your student has not sent us their scores, they still can. If they have not taken the SAT or ACT, they must complete the Writing and Math placement tests.

Students should Complete the Course Selection Questionnaire (CSQ) to determine if they need to take the Math or Writing Placement! Please remind your student to check their Central email for a message titled, "It's time to start planning your Fall 2025 academic schedule!", which includes the CSQ.

FERPA

What is FERPA:

The Family Educational Rights and Privacy Act (FERPA) is a federal law that affords parents the right to have access to their children's education records, the right to seek to have the records amended, and the right to have some control over the disclosure of personally identifiable information from the education records. When a student turns 18 years old, or enters a postsecondary institution at any age, the rights under FERPA transfer from the parents to the student.

A <u>FERPA FORM</u> at Central Connecticut State
University (CCSU) is a document used to manage
the privacy of student education records.It also
allows students to authorize CCSU to release their
records to specific individuals or organizations

We ask that the students take the lead to initiate this form.
