Applying for Admission

For consideration, applicants must submit the following:

1. A completed online application with supplemental materials (ccsu.edu/apply):
 - Two letters of recommendation from individuals who know your academic competence, character, or professional work. Note: Personal references will not be accepted.
 - Essay describing your:
 - Personal and professional experience and reasons that influenced you to pursue the field of Marriage and Family Therapy
 - Personal characteristics you believe will contribute to your success in the Central Marriage and Family Therapy program as well as your success as a Marriage and Family Therapist after graduation
 - Definition of family
 - Personal and/or professional experiences you have had with people from diverse cultural backgrounds
 - A current resume
2. Official undergraduate and graduate transcripts from a regionally accredited institution of higher education (GPA of 2.70 or higher)
3. Qualified applicants will be invited for an interview
