  - 2.2. Explain how courses and other activities fit into a degree program (general education, major, minor, program admission requirements, professional, electives, and special requirements)
  - 2.3. Select courses and activities that meet all components of a degree program (general education, major, minor, program admission requirements, professional, electives, and special requirements)

- 2.4. Use the degree evaluation system
- 3. Understand and follow university policies and procedures
  - 3.1. Explain and follow academic standards and regulations as listed in the undergraduate catalog
  - 3.2. Describe and follow course registration procedures within established timelines
  - 3.3. Apply for graduation within established timelines
- 4. Understand and apply strategies for academic success
  - 4.1. Evaluate academic and personal strengths and weaknesses
  - 4.2. Meet with an academic advisor
  - 4.3. Set academic goals and describes steps needed to achieve them
  - 4.4. Prepare a comprehensive individualized academic plan for graduation
  - 4.5. Develop connections with faculty to enhance the academic experience
- 5. Plan and integrate their academic program into their career goals
  - 5.1. Explore career goals
  - 5.2. Choose a major appropriate for the fulfillment of their goals
  - 5.3. Discuss career goals with an advisor and use other resources to search for and participate in related experiential activities
  - 5.4. Research and describe post-graduation educational opportunities
