- b. Job Place Bullying and Harassment (Kathy Hermes)

Attendance: Carolyn Fallahi, Kathy Hermes, Lou Pisano (HR)

November 8, 20120: Discussed the Bullying Policy. Explained that we wrote this draft when Anne Alling was the head of HR and that she didn't get a chance to work on it before she left. In the past, a policy from this committee was sent to the Executive Committee. They wanted a policy that emphasized verbal abuse, but they weren't sure about violence issues. This committee felt that we would have to reach a high level of psychological intimidation to have a response with the old policy. Kathy gave examples of more subtle forms of intimidation that she was made aware of by employees. Lou stated that he is going to investigate whether or not we need a policy. He emphasized that he wants to hear about bad behavior on the part of employees and that he doesn't necessarily need a policy to deal with that. Kathy emphasized that the language of this policy is in line with the language of several bullying bills that are being introduced to different states.

Women's luncheon committee Meeting was cancelled due to Hurricane Sandy. Committee will meet on November 13. Have tentatively booked the Connecticut Room for March 6 and March 14. Committee has received a list of 53 innovative, outstanding women from across Connecticut who were honored in 2012, during the eighth annual Women of Innovation awards meeting. The Connecticut Technology Council, recognizes women in the workforce and at the high school and college levels, who are innovators, role models and leaders in the technology, science and engineering fields. Hopefully, the committee can invite a woman from this group to be our speaker.

e. Work Life Family Balance (Fiona Pearson & Leah Glaser)

The WLB subcommittee met on October 23rd. Present were Leah Glaser, Fiona Pearson, Jacqueline Cobbina-Boivin, Kim DeMichele, Karen Ritzenhoff and Laurie Dunn.

Below is a list of topics/items discussed:

- 1) We discussed the new lactation room currently located in the EB Library on the 4th floor. We need to ensure that the room is equipped with comfortable furniture and a refrigerator. Leah has in her office a refrigerator that was supplied by the University when she was nursing that could be moved to the new lactation room. Jacqueline stated that the Women's Center has posted signs across campus advertising the new lactation room in the library. When construction begins on the 4th floor of the library, that lactation room will move--we are not sure to where it will move. Finally, Laurie stated that she will follow-up to ensure that furnishings and equipment are provided for the lactation room(s) in the new Arts and Sciences building.
- 2) We briefly discussed the importance of promoting WLB on CCSU's campus. Jacqueline offered to help by enlisting some of her student workers in the RB Women's Center to create promotional posters. We hope to promote the WLB website and facebook page with these posters.
- 3) Kim provided information regarding several funding sources for the pilot drop-in service that we hope to offer in the 2013-14 academic year. Fiona and Kim will work together to apply for these grants which are due in January and February.
- 4) Leah and Fiona shared information from their Oct. 9 meeting with Deans Sakofs and Pease and Oct. 18 meeting with Dean Lemma. During those meetings Leah and Fiona discussed the future of the Family Resource Center that is now included in the 2020 Master Plan and discussed possible funding sources for the drop-in site.
- 5) Fiona shared information regarding her meeting with the AAUP Executive Board on Oct. 10. CCSU's AAUP has agreed to help us in funding the pilot drop-in site and would like to put in an additional request for funding from CSU's AAUP. Fiona has also contacted SUOAF but is awaiting their response.

Book description from Amazon.com: February 21, 1965: Malcolm X is assassinated in Harlem's Audubon Ballroom. June 23, 1997: After surviving for a remarkable twenty-two days, his widow, Betty Shabazz, dies of burns suffered in a fire. In the years between, their six daughters reach adulthood, forged by the memory of their parents' love, the meaning of their cause, and the power of their faith. Now, at long last, one of them has recorded that tumultuous journey in an unforgettable memoir: *Growing Up X*.

Born in 1962, Ilyasah was the middle child, a rambunctious livewire who fought for—and won—attention in an all-female household. She carried on the legacy of a renowned father and indomitable mother while navigating childhood and, along the way, learning to do the hustle. She was a different color from other kids at camp and yet, years later as a young woman, was not radical enough for her college classmates. Her story is, sbove all else, a tribute to a mother of almost unimaginable forbearance, a woman who, "from that

day at the Audubon when she heard the shots and threw her body on [ours, never] stopped shielding her children."

- f. Sexual Assault Protocol (Sexual and Relationship Violence Prevention) (Joanne DiPlacido) Met on October 11, 2012. Report below:
  - i. Name Change to **Sexual and Relationship Violence Prevention** and New Goals: The Sexual Assault Protocol Sub-Committee was originally

started as a way of promoting new policies related to sexual assault. As those policies have been created and implemented, we decided that it was time to focus on new goals and change our name. We decided that we wanted to focus more on relationship violence and prevention. Given that end, we voted to change our name to the Sexual and Relationship Violence Prevention Sub-Committee.

- ii. Goals for this year: Programming around sexual assault violence month in April. Thus far: a. April 10<sup>th</sup> Take Back the Night. b. CCW is going to co-sponsor the 5K Enough Race Against Violence April 21, 2013. With the race against violence, we are asking for money to support this event. Last year we requested and \$1,000, which covered food, t-shirts, etc.
- iii. Upcoming Events: Slut Walk, but the handout has the wrong times. They contacted Jason to speak at 4, but the handout says that it starts at 4:30 p.m. on October 30<sup>th</sup>. We will check with Jackie about the times.
- iv. Things to follow up on: Stalking Policy. Carolyn will contact HR and see how that policy is progressing. Template for colleges. See if anything needs to be changed.
- v. One possible goal: Survivors and Resource Panel for students.
- vi. We were updated about Orientation. Sex Signals (theater group) performed at Orientation and talked about sex, consent, etc. Did it through roll plays, miscommunication, the wrong signals, brought it down to their level so they have a better understanding. The students were given handbook. Also doing the sexual assault presentations with Jackie and the YWCA. The presenters have been well received. Being done in the residence halls. These trainings will continue in the month of October. Jason's Men's group was there in the residence halls and it went well. Going into another dorm next week. With Orientation, after Sex Signals, Sandy's staff went over campus resources. Brochures were passed out. The group considered doing a panel at Orientation. Sandy noted that if we were to propose anything else at Orientation, we would need to speak with Ray Hernandez. If we want to recommend and have a panel in addition to Sex Signals, we would have to go through him to get it part of the program. That doesn't mean we have to wait until orientation; we can do it at another time as well.
- vii. All the programming in the past has been faculty based. It would be interesting to have a student run gripe session, where things could improve, on the model of what they did with advising?
- viii. Bobbie talked about a past program at CCSU called the Student Assistance Program: trained for a week; our pictures on campus; people who students went through anyway; so in a situation like that we were trained in a number of hot spots. Went for 5 or 6 years about 15 years ago.
- ix. What types of prevention programs would students like to see? The SART committee had a best practices committee. Joanne and Sandy were going to try and work with them. Idea: Jaclyn, have the

beginning alcohol test that incorporates sexual assault information. Also can talk with Megan Wenz in alcohol (EW: alcohol. Edu). She might be a good person to take it. Jaclyn will speak with Megan and find out their status. If she is not the right person, she can tell us who to speak with.

- x. We want to coordinate programming for the sexual assault month in April with the Women's Center. Also, for next October, we would like to begin planning for programming for Domestic Violence Awareness Month.
- g. Sexual Minorities (Ellen Retelle) Scheduling meeting later in October. Info from LGBT Advisory, will schedule a meeting of subcommittee later in October.
